The student has attended the school of origin for only a brief time.</p>
<input type="checkbox"/>	<p>Academic strength The child's academic performance is weak, and the child would fall further behind if he/she transferred to another school.</p>	<input type="checkbox"/>	<p>Academic strength The child's academic performance is strong and at grade level, and the child would likely recover academically from a school transfer.</p>
<input type="checkbox"/>	<p>Social and emotional state The child is suffering from the effects of mobility, has developed strong ties to the current school, and does not want to leave.</p>	<input type="checkbox"/>	<p>Social and emotional state The child seems to be coping adequately with mobility, does not feel strong ties to the current school, and does not mind transferring.</p>
<input type="checkbox"/>	<p>Distance of the commute and its impact on the student's education and/or special needs The advantages of remaining in the school of origin outweigh any potential disadvantages presented by the length of the commute.</p>	<input type="checkbox"/>	<p>Distance of the commute and its impact on the student's education and/or special needs A shorter commute may help the student's concentration, attitude, or readiness for school. The local attendance area school can meet all of the necessary educational and special needs of the student.</p>

The student will benefit from the continuity offered by remaining in the school of origin.</p>	<input type="checkbox"/>	<p>Length of anticipated stay in a temporary shelter or other temporary location The student's current living situation appears stable and unlikely to change suddenly; the student will benefit from developing relationships with school peers who live in his local community.</p>
